Sub: Re-appointment of Mr. Pradeep Poddar as an Independent Director for a second term of three years w.e.f. September 15, 2019.

The Board of Directors of the Company, at the recommendation of the Nomination and Remuneration Committee and subject to approval by the shareholders, has re-appointed Mr. Pradcep Poddar, the Independent Director of the Company whose tenor is expiring on September 14, 2019, as an Independent Director of the Company for second term of appointment as an Independent Director with effect from September 15, 2019 to hold office for three consecutive years ending on September 14, 2022."

Mr. Poddar aged 64 years is a non-executive and an independent director of our Company. He has completed his Bachelors' degree in Chemical Engineering from the University Department of Chemical Technology, University of Mumbai in 1976 and a postgraduate program in management from Indian Institute of Management, Ahmedabad, in 1978. He has significant experience in consumer goods industry, having worked in Glindia Limited (formerly known as 'Glaxo Laboratories (India) Limited'), Heinz India Private Limited and TATA Group. He represented the Tata's on the Nourishco Board (Joint Venture with Pepsi). He is also on the Boards of Monsanto India Limited, Polycab Limited, and Uflex Limited.

Further note that Mr. Pradeep Poddar is not debarred from holding the office of director by virtue of any SEBI order or any other such authority. Kindly take note of the above.
